## PROS:

# VISA & RESIDENCY OPTIONS



DEPENDING ON YOUR SITUATION, HERE  
ARE SOME OF THE MOST COMMON  
WAYS TO LEGALLY STAY IN SPAIN:

- Digital Nomad Visa: For remote workers with contracts outside Spain.
- Non-Lucrative Visa: For retirees or those with passive income.
- Golden Visa: For those investing significantly in property or business.
- Student Visa: For those enrolling in academic programs.
- EU Citizen Rights: If you're from the EU/EEA, the process is simpler but still involves paperwork.

Each option has unique requirements. It's important to start early and seek guidance where needed.



# FINANCIAL PLANNING



Before making the move, take time to plan your finances:

- Cost of Living: Rent, groceries, and utilities vary greatly by region.
- Banking: Opening a Spanish bank account can be time-consuming but is essential.
- Insurance: Health insurance is required for most visa types.
- Taxes: Research double taxation agreements and local tax obligations.

Pro tip: Track your monthly budget for 3 months before the move to get a sense of your lifestyle needs.

- Cádiz & Surroundings: Laid-back lifestyle, authentic culture, and lower living costs.
